The Thiells-Roseville Fire District is soliciting sealed bids for the furnishing of all labor, materials, and equipment necessary to perform polymer flooring work on approximately 2,423 square feet of designated floor space within the Fire District's Sub-Station Fire House located at 120 Hammond Rd., Thiells NY 10984.

#### Scope of Work Includes:

- Mechanical surface preparation including shot blasting and grinding
- Pre-filling of surface divots greater than 2"
- Application of epoxy primer, resurfacer (power troweled to ¼" nominal thickness), epoxy grout coat, and final polyurethane coat
- Installation of flexible joint material
- Grinding, cleaning, and final surface preparation between each coat
- Installation of 4" integral cove base
- Minimum of a 5 year warranty

All work is to be completed in accordance with industry standards or equivalent. Work is expected to be completed within 10 days of starting.
